We are currently accepting vendor applications for Quality Merchandise or Original Fine Arts & Crafts. Please, no Flea Market Dealers!

Thousands attend. We offer 5 Stages featuring local Bands (from Jazz to Rock & Roll), outside and inside Dining at our restaurants, Informational Booths, and Theme Events. This is a phenomenal opportunity to reach thousands of potential customers in a few hours. Vendors supply their own tables, tents, and battery powered lighting. This year, we will be transferring the Food Court to South Ocean Ave., in front of the Blue Point Brewery, and the Capital One Bank Plaza will become a Children's area. We also hope to have enough Vendors sign up, that we will be able to extend our selling area from Maple Ave., down to the Courthouse. In addition to the Suffolk County's Fifth Precinct and the Village Code Enforcements presence, we will have 18 private security guards on hand each evening, and we will be manning each entrance to the Event, so that children under 18, unless accompanied by a parent, will be unable to enter.

Main Street is closed east to west from Maple Ave. to West Ave. Booths are 10 x 10 and prices are based on location. You must attend all 4 nights. There are no rain dates. \$100 deposit must accompany each Application, and the balance will be due July 1st.

ELIGIBILITY

Quality merchandise, original Fine Art, or handmade crafts. No Flea Market dealers.

No Rain Dates

Set Up: 5 PM SHARP. All vehicles must be removed from the street by 5:45 p.m. Arrive no later than 5:30 p.m. NO EXCEPTIONS. No early break down. **Vehicles will not be permitted back on site until 10:00 p.m.**

CONDITIONS

All Vendors will be located in the center of the street, and will extend 10 feet back toward the curb. The space in between the sidewalk and the back of your booth must be left open and accessible. Vendors are responsible for keeping their displays clean. All trash and boxes are to be taken with you. No refuse to be left on the street or on the curb or in receptacles on the sidewalk. No electric service. Battery operated lanterns are recommended.

Any merchandise deemed by the committee objectionable and not in keeping with our family atmosphere must be removed. Nuisance items such as Silly String, spray paint, toy guns, knives, fireworks of any kind, etc. are prohibited from the event and cannot be sold by Vendors. Any non-compliance with the above stated rules or state and local regulations will result in expulsion from the Event without refund or further recourse. Judgment by the Committee is final.

REGISTRATION and FEES

Pre-registration by application only. Deadline: April 18, 2009 with non-refundable deposit of \$100.00. Fees: \$300.00 for all 4 nights for one (1) 10 X 10 foot space, located between the Patchogue Theatre and the BrickHouse. \$250 for 4 nights for a space between the Theatre and Maple Ave. \$225 for a space between the BrickHouse and Courthouse. We will do our best to accommodate requests for placement. No Refunds due to inclement weather. Balance due July 1, 2009.
